



BIOGRAPHIES

Peter Appleton has worked in the museum & gallery field for over twenty years at cultural institutions including the National Museum of Ireland and the Queensland and Western Australian Museums. Since 2008 he's worked in Canberra at the National Film & Sound Archive and the National Library. For the last five years he's been the chair of the Disaster ACT (DISACT) group of Canberra-based collection managers and conservators that meets regularly to discuss collection disaster preparedness and response.

Kathryn Dan joined the ANU as University Archivist in October 2018, overseeing the Archives and Records programs. Before moving to the ANU, Kathryn was at the University of Melbourne, where she was Associate Director, Information Governance in the Legal and Risk portfolio. Kathryn has previously served as President of the Australian Society of Archivists, on committees of the International Council on Archives, and was a member of the Standards Australia committee on records management.

She works on arrangement and description, reference, and repository management for the Noel Butlin Archives Centre and University Archives programs, mostly on business and labour records.
