### Sources of law in australia

The legal system is built on different forms of law



#### Constitution

Supreme law

#### **Statute Law**

Made by the Government at State and Federal levels

#### **Common Law**

Built on precedent made by the courts

Follows court hierarchy

#### DOCTRINE OF PRECEDENT

Courts use the judgments and principles set out by earlier decisions when determining their own outcomes.

Higher court decisions have more precedence than smaller courts - High Court of Australia is the top of this pyramid.




THe Court hierarchy

- R = Regina or Rex (the sitting Queen or King)





### Case Law: Tips & tricks

What if you don't know what an abbreviation stands for?

- Cardiff Legal Abbreviations
- A "C" in the abbreviation usually stands for court which lets you know it is unreported: NSWSC, HCA, QCA






#### Escape room
